Correct Answer: A

Explanation: The maximum number of snapshots allowed per MTree is 750. Warnings are sent when the number of snapshots per MTree reaches 90% of the maximum allowed number (from 675 to 749 snapshots), and an alert is generated

when the maximum number is reached. To clear the warning, expire snapshots and then run the file system cleaning operation.

Note: To identify an MTree that is nearing the maximum number of snapshots, check the Snapshots panel of the MTree page regarding viewing MTree snapshot information.
