Whenever you\\'re not sure which word is correct, read the sentence aloud and substitute "its" and "it\\'s." Would it make sense to say "It is not my fault" or "the car has a dent in it is rear bumper"? Obvious works in the first part of the sentence, but not in the second. "It\\'s" and "its," therefore, are used correctly in example.
